**EMERGENCY FIRE CLOSURE-SALT CREEK FIRE**

**PROHIBITIONS:**

Pursuant to Title 36 CFR 261.50 (a) and (b) the following act is prohibited on the area, roads, and trails as described in this order, all within the Sanpete Ranger District, San Pitch Division of the Manti-La Sal National Forest until further notice.

1. Going into or being upon an area. 36 CFR 261.52(e)
2. Public Safety. 36 CFR 261.53(e)

**EXEMPTIONS:**

Pursuant to 36 CFR 261.50 (e) the following persons are exempt from this order:

1. Persons with a permit specifically exempting them from the effect of this Order.
2. Any Federal, State, or local officer, or member of an organized rescue or firefighting force in the performance of an official duty.

**AREA DESCRIBED:**

*All National Forest System Lands located within the areas affected by the Salt Creek Fire located in Juab County, Utah:*

*Township 13 South; Range 1 East, Sections 13; Township 13 South, Range 2 East, Sections 7, 18, 19, 27, 28, 30, 31, and 33; Township 14 South, Range 2 East, Sections 4, 5, 6, 8, and 9.*

*All National Forest System Lands located within the areas affected by the Salt Creek Fire located in Sanpete County, Utah:*

*Township 13 South, Range 2 East, Sections 28 and 33; Township 14 South, Range 2 East, Sections 4 and 9.*

*As depicted on attached map (EXHIBIT A).*

**Roads and Trails affected by Fire Closure:**

- *Rocky Ridge Canyon Road (Forest Service Road (FSR# 154).*
- *Log Hollow Road (FSR # 069).*
- *Red Cliff Road (FSR # 127).*


**PURPOSE:**

The purpose of the ORDER is to protect life and property due to hazards from the Salt Creek Fire.

**IMPLEMENTATION:**

1. This Order will be in effect when signed and shall remain in effect until further notice.
2. A map identifying the closure area is attached and made part of this Order.
3. Any violation of this prohibition is punishable by a fine of not more than \$5,000.00 for an individual or \$10,000 for an organization, and/or imprisonment for not more than six (6) months. [Title 16 USC 551, Title 18 USC 3571(b) (6), Title 18 USC 3581 (b) (7)].
4. This Order supersedes any previous orders prohibiting the same acts covered by this Order in the above-described area.
