

**ORDER
MCRAE FIRE PLANNING AREA CLOSURE
KAIBAB NATIONAL FOREST
TUSAYAN RANGER DISTRICT**

Pursuant to 16 U.S.C. 551, and 36 CFR § 261.50(a), the following acts are prohibited on National Forest System lands within the Tusayan Ranger District, Kaibab National Forest, in Coconino County within the state of Arizona. The closure area is depicted on the attached map, hereby incorporated into this Order as Exhibit A.

PROHIBITIONS:

1. Going into or being upon the area; **36 C.F.R § 261.52(e)**.
2. Being on a road; **36 C.F.R. § 261.54(e)**.

EXEMPTIONS:

Pursuant to 36 CFR § 261.50(e), the following persons are exempt from this order:

1. Any Federal, State, or local officer, or member of an organized rescue or firefighting force or other authorized personnel in the performance of an official duty.
2. Persons with a written Forest Service permit that specifically authorizes the otherwise prohibited act.

AREA DESCRIPTION:

National Forest System lands bounded to the east by FSR 2725, to the south by FSR 305, to the west by U.S. Highway 64 and to the north by FSR 688.

The following roads will be closed:

FSR 305AH	FSR 2703
FSR 305A	FSR 2703A
FSR 305AC	FSR 305AD
FSR 305AB	FSR 308


PURPOSE:

This Order is necessary to protect public health and safety due to fire management activities.

IMPLEMENTATION:

1. This Order becomes effective at 8:00 a.m., July 26, 2014, and will remain in force until rescinded or until August 15, 2014, whichever event occurs first.
2. This Order rescinds, replaces and supersedes any previous Orders prohibiting the same acts covered by this Order in that area addressed in Exhibit A.




Exhibit A
