Current fire situation: There has been no growth of the fire perimeter in the last 6 days. There were strong winds last 24 hours but no spots were detected outside of containment lines. Stump holes and logs within the interior of the fire will continue to smolder.

Today, crews will continue to repair damage caused by fire suppression actions. There are approximately 116 miles of fireline to be repaired. Crews have completed almost 28.9 miles of the repair work. Another 17.5 miles are pending approval by resource advisors. Hose and pumps are being removed from areas where the fire is out and there is no longer a threat. Firefighters will continue to work on areas that are still hot adjacent to uncontained firelines and patrol in other areas.

Due to lack of fire activity, no future night shifts are planned.

Weather and Safety: The weather is expected to cool during mid-week to below normal and warm toward the weekend..

The public is encouraged to use caution driving as recent rain may cause more logs and rocks to fall onto roadways and heavy firefighting traffic will remain in the area.

Evacuations and Closures:

All County roads are now open and all evacuation advisories have been lifted. The Forest Closure and associated road closures remain in effect (see details below).

A Forest Closure (Order No. 14-15-05) is currently in effect. The closure prohibits going into or being upon National Forest System lands or Forest Service roads within the Fork, South, Route and Mad River Complex Fire Closure Areas.
