FOREST ORDER No. 06-10-24-15-12

EMERGENCY AREA CLOSURE FOR PUBLIC HEALTH AND SAFETY

Pursuant to 36 CFR § 261.50(a) and (b), the following act is prohibited within the High Cascades Ranger District as described below and as depicted in map attached as Exhibit A, located within the Rogue River Siskiyou National Forest from August 11, 2015 until October 31, 2015, unless sooner rescinded.

- 1) Being in an area closed for public health and safety. [36 CFR § 261.53(e)]

From the junction of State Highway 230 and Forest Road 6530 east, following the Jackson and Douglas County line to the Crater Lake National Park boundary (T.29S, R.4E, Sections 32, 33, 34, 35, 36; T.29S, R5E, Section 31). Then heading north following the park boundary to the Douglas and Klamath County line (T.29S, R5E, Sections 7, 18, 19, 30). Then following the park boundary east to the High Cascades Ranger District, Diamond Lake Ranger District boundary (T.29S, R.5E, Sections 7, 5, 4, 3. T.28S, R.5E, Sections 34, 35, 36). Then north back to State Highway 230 along the High Cascades Ranger District, Diamond Lake Ranger District boundary (T.28S, R.5E, Sections 36, 35, 26). Then south on Highway 230 to close the loop.

Pursuant to 36 CFR § 261.50 (e), the following persons are exempt from this Order:

1. Persons with a permit specifically authorizing the otherwise prohibited act or omission.
2. Any Federal, State, or local officer, or member of an organized rescue or firefighting force in the performance of an official duty.
3. Persons who are using National Forest land strictly for direct and lawful access to or from private property.

This prohibition is in addition to the general prohibitions in 36 CFR Part 261, Subpart A.

A violation of this prohibition is punishable by a fine of not more than \$5000.00 for an individual or \$10,000.00 for an organization, or imprisonment for not more than six months, or both. 16 U.S.C. § 551; 18 U.S.C. §§ 3559 and 3571.

This Order is effective immediately.


