ORDER NO. 06-10-24-17-29

Emergency Trail and Area Closure – Broken Lookout Fire

Pursuant to 16 USC § 551 and 36 CFR § 261.50 (a) and (b), the following acts are prohibited in the High Cascades Ranger District within the Rogue River-Siskiyou National Forest as described below and shown in Exhibit A. This Order will be effective beginning August 30, 2017 and ending December 31, 2017, unless sooner rescinded.

PROHIBITION:

1. Going onto or being within an area closed for public health and safety. [36 CFR § 261.53 (c)]
2. Being on a closed trail. [36 CFR § 261.55(a)]

AREA CLOSURE DESCRIPTION:

Closure area is described as beginning at the Woodruff Bridge where the 68 road crosses the Rogue River, heading north along the Rogue River to the point where State Highway 230 crosses the Rogue River in Section 6 of T.30 S., R.4 E., thence northerly along Highway 230 to the junction of Forest Road 6540 in Section 20 of T.29 S., R.4 E., thence northwest along the 6540 to the junction of the 6540500, thence northwest along the 6540500 to the Hole-In-The-Ground Trail (1047) trailhead at the end of the road, thence northwest along the trail to the junction of the Rogue Umpqua Divide Trail (1470), thence north to its junction with the Forest Boundary, thence south and west along the Forest Boundary to its junction with the 6640800 road in Section 7 of T.31 S., R. 2 E., thence southeast along the 6640800 to the junction of the 6640 road, thence south along the 6640 to the junction of the 6470 road, thence southeasterly along the 6470 to the junction of the 64 road, thence easterly along the 64 road to the 68 road, thence south along the 68 road to Woodruff Bridge, the point of origin.

TRAIL CLOSURE DESCRIPTION:

EXEMPTIONS:

Pursuant to 36 CFR § 261.50(e), the following persons are exempt from this order:

1. Persons with a permit specifically authorizing the otherwise prohibited act or omission.
2. Any Federal, State, or local officer, or member of any organized rescue or fire fighting force in the performance of an official duty.

This prohibition is in addition to the general prohibitions in 36 C.F.R. Part 261, Subpart A.

Violations of this prohibition is punishable as a Class B Misdemeanor, by a fine of not more than \$5,000 for an individual or \$ 10,000 for an organization, or imprisonment for not more than 6 months, or both (16 USC § 55 1; 18 USC § 3559 and 18UJSC § 3571).
