**FLY CANYON FIRE AREA ROAD AND TRAIL CLOSURE**

**PROHIBITIONS:**

Pursuant to Title 36 CFR 261.50(b) the following acts are prohibited in the area, roads, and trails as described in this order, all within the Ferron/Price Ranger District, Manti-La Sal National Forest.

1. Going into or being upon an area, 36 CFR 261.53(e).
2. Being on a road, 36 CFR 261.54(e).
3. Being on a trail, 36 CFR 261.55(a).

**EXEMPTIONS:**

Pursuant to 36 CFR 261.50 (e) the following persons are exempt from this order:

1. Persons with a permit specifically exempting them from the effect of this Order.
2. Any Federal, State, or local officer, or member of an organized rescue or fire fighting force in the performance of an official duty.
3. Federal or State administrative personnel in the performance of an official duty.

**ROADS AND TRAILS DESCRIPTION:**

**Forest Road 0038:** Lowry Water road from the junction with Forest Road 0014(Millers Flat Road) to the junction with Forest Road 0271(Potters Pond).

**Forest Road 0271:** Potters Canyon Road from the junction with Forest Road 0014(Millers Flat road) to the junction of Forest Road 0150(Skyline Drive road)

**Forest Roads: 2228; 2232; 2217; 2213; 2209; 2207; 2206; 2212; 2211; 2340:** The roads in the vicinity of the Potters Pond Campground and Lowry Water drainage.

**Forest Trail 087:** Black Canyon Trail from the end of Black Canyon Road to junction with Lowry Water Road.

**AREA DESCRIPTION**

The area depicted on the attached map, within the boundaries described as follows; from Forest Road 0038 at Black Canyon west along the private land boundary to the north west corner; from the north west corner of the private land west along the northern Reader Ridge to Little Mountain Peak; west from Little Mountain Peak along the ridge to South Tent Mountain and northwest to North Tent Mountain; northeast from North Tent Mountain along the meadow fork ridge across the bottom of Black Canyon and northeast on the Lowry Top ridge to Lowry Top Peak; northwest along Lowry Top Ridge Road 273 to Skyline drive; north along skyline drive to Potters Canyon Road; east along Potters Canyon Road(Forest Road 0271) to the junction with Lowry Water Road (Forest Road 0038); South along Forest Road 0038 to the corner of the private land boundary

**PURPOSE:**

To provide for public and firefighter safety during firefighting operations.

**DEFINITION:**

See the attached map for a visual representation.

**IMPLEMENTATION:**

1. This Order will be in effect when signed and shall remain in effect until October 7, 2016 or until rescinded, whichever is earlier.
2. Violation of the above prohibition(s) is punishable by a fine of not more than \$5,000.00 for an individual or \$10,000.00 for an organization, and/or imprisonment for not more than six (6) months. [Title 16 USC 551, Title 18 USC 3571(b) (6), Title 18 USC 3581 (b) (7)].

**1. Background:** The Fly Canyon was started by lightning and has been managed for resource benefits. The previous Closure has been terminated and replaced by this order.


**2. Intent of Subpart B Order:** To provide the legal ability to restrict use of the area and roads described to provide for public access and safe conditions for fighting fire.

**3. Enforcement Plan:** A cooperative effort will be accomplished by personnel from Forest Service LEI, Forest Protection Officers, Emery County Sheriff's Office, Sanpete County Sheriff's Office, Forest Service Fire Management Officials, and United States Attorney Offices in Utah. SEC2 or Forest Service Forest Protection Officers will be assigned to 24 hour coverage at Lowry Water/Millers Flat Junction, Potters Pond/Millers Flat Junction, and east of Potters Pond on the Potters Canyon Road. Educational efforts will include notice on the Manti-La Sal Facebook page and signing of the area to bring the prohibition to the attention of the public. If voluntary compliance is not accomplished a violation notice will be issued to the violator(s).


